Dear Applicant,

Human Resources has now implemented new rules about the application/Hiring process

- <u>1.</u> When applying you now have to state your family members and who they are, <u>IF</u> they work in the department you're applying for.
- 2. If the applicant has an <u>EMERGENCY</u> and cannot make the interview call they are allowed only one more call so the Director can make a choice on who to hire.
- **<u>3.</u>** If the applicant misses their first interview, they cannot interview for a certain amount of time, which is 90 days.
- <u>4.</u> If the applicant is hired and starts with the department <u>THEY</u> applied for, they cannot apply or transfer to another Position/Department until they have completed their 90 introductory period with <u>NO WRITE UPS.</u>
- 5. If applicant is selected for a job and <u>DOESN'T</u> show up for processing they cannot apply for another job for <u>90 days</u>.
