

**MESCALERO APACHE TRIBE  
MESCALERO, NEW MEXICO**

**ORDINANCE 14-03**

**WHEREAS**, the Mescalero Apache Tribe an Indian tribe organized under the Indian Reorganization Act of June 18, 1934 (25 U.S.C § 476), and under its Revised Constitution, has full power to act for the Tribe; and

**WHEREAS**, pursuant to Article XI, Section 1(i) of the Revised Constitution, the Mescalero Apache Tribal Council has the power to represent the Tribe and act in all matters that concern the welfare of the Tribe and to make decisions not inconsistent with, or contrary to, the Revised Constitution; and

**WHEREAS**, pursuant to Article XI, Section 1(l) of the Revised Constitution, the Mescalero Apache Tribal Council has the power to administer any funds or property within the exclusive control of the Tribe, and to make expenditures from available funds for public purposes of the Tribe; and

**WHEREAS**, the Mescalero Apache Tribal Council wishes to encourage and assist all its members to attain the highest possible level of education; and

**WHEREAS**, the Mescalero Apache Tribal Council wishes, to the best of its ability, to provide financial assistance to those Tribal members meeting the qualifications set forth; and

**WHEREAS**, scholarship funds are intended to provide assistance to Tribal members for higher education costs that cannot be met through other programs or resources;

**WHEREAS**, the Mescalero Apache Tribal Council adopted Ordinance 09-09 in order to govern the scholarship Program and the disbursement of scholarship funds thereunder; and

**WHEREAS**, the Mescalero Apache Tribal Council believes that it is necessary to make revisions to the Ordinance as provided in Attachment "A."

**NOW, THEREFORE, BE IT ORDAINED** that the Mescalero Apache Tribal Council does hereby adopt certain revisions to Ordinance 09-09, such revisions are attached hereto as Attachment "A."

**BE IT FURTHER ORDAINED** that all contrary provisions are hereby repealed.

**ORDINANCE**

The foregoing enactment of the Mescalero Apache Tribal Council is duly adopted and approved on the 28<sup>th</sup> day of July 2014, at legally called session of the Mescalero Apache Tribal Council, by a vote of 8 for and 0 opposed, with 0 abstaining and 0 absent at which quorum was present and at which a majority of the members voted in favor thereof. This enactment is approved by the President of the Mescalero Apache Tribe under authority of Article XII, Section 1, of the Revised Constitution.
